- Provide a dedicated customer service team for Plan Participants and their covered dependents.

The drugs included in the Plan's Formulary are subject to change from time to time by CVS Caremark if accepted by the Plan. All drug lists, including the CVS Performance Drug List, the Medications Requiring Prior Authorization for Medical Necessity, and the High Deductible Health Plan Preventive Therapy Drug List, as applicable, are updated quarterly and are available on **cooperative.com > My Benefits > My Insurance > Manage Your Prescriptions > Plan & Benefits.** If you are unable to access this website, call NRECA's Member Contact Center (MCC) for a copy of the list at no cost to you.
